There being no other individuals wishing to speak, Council Vice President George closed the Citizens' Forum.

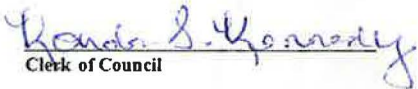
Meeting Recess

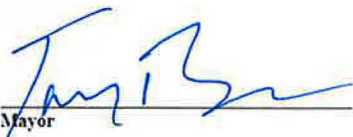
